## **MEMORANDUM OF ASSOCIATION**

### **1. NAME OF THE ASSOCIATION**

The name of the association shall be “**KARNATAKA SPORTS FACILITY OWNERS ASSOCIATION**”, which is registered under the Karnataka Societies Registration Act of 1960 and rules framed hereunder.

### **2. REGISTERED OFFICE**

The registered office of the association shall be situated at no 1087/165/13, 165/14, Doresanepalya, Puttenahalli Road, IIMB post, Bengaluru -560076.

### **3. JURISDICTION**

The Association shall function in the territories comprised in the state of Karnataka.

### **4. OBJECTS OF THE ASSOCIATION :** The objects of the association shall be

1. To promote, establish, run, organize, and develop indoor and outdoor sports or games for the benefit of the public and to members.
2. To promote welfare programs of the business & the welfare of members.
3. To watch over, promote and protect the mutual interest of members.
4. To render required civic service to the members.
5. To unify and develop better understanding and co-operation between the different representatives' organizations affiliated with the Karnataka Sports Facility Owners Association hereinafter called **KSFOA**.

6. To co-ordinate and if required to supervise the activities of the affiliated members. **KSFOA** decision is final regarding any dispute that may arise from its affiliated organizations.

7. To establish, promote or assist in establishing or promoting and to subscribe to, or become a member of any other association whose objects are similar either in full or in part to the objects of **KSFOA**.

8. To do all such other lawful things as are incidental or conducive to the attainment of the above objects.

9. To establish, maintain, and reinforce contacts with and to render help and assist all members in their problems.

10. To represent any statutory bodies or any authorities from time to time for the common welfare.

11. To represent before any statutory authorities, the members of the Association in all matters about their common problems in the business and settle or compromise with common problems of members.

12. The bye laws are not in substitution of but are in addition to the Act and Rules formulated in order to meet the specific requirement of the Association.

13. The Association shall not act beyond the scope of its object without duly amending the provision of these Bye-laws for the purpose.

14. The provisions of the act and rules shall prevail over these Bye-laws in the event of any conflict or requirement of interpretation. Any amendment of these Byelaws shall be done only with approval at the Annual General Meeting or a Special General Meeting called for this purpose.

15. The Association shall carry out donation camps, charity events and render support to economically backward classes in regard to Sports activities.

16. The bye laws of the association are applicable to the all members of **KSFOA**.
